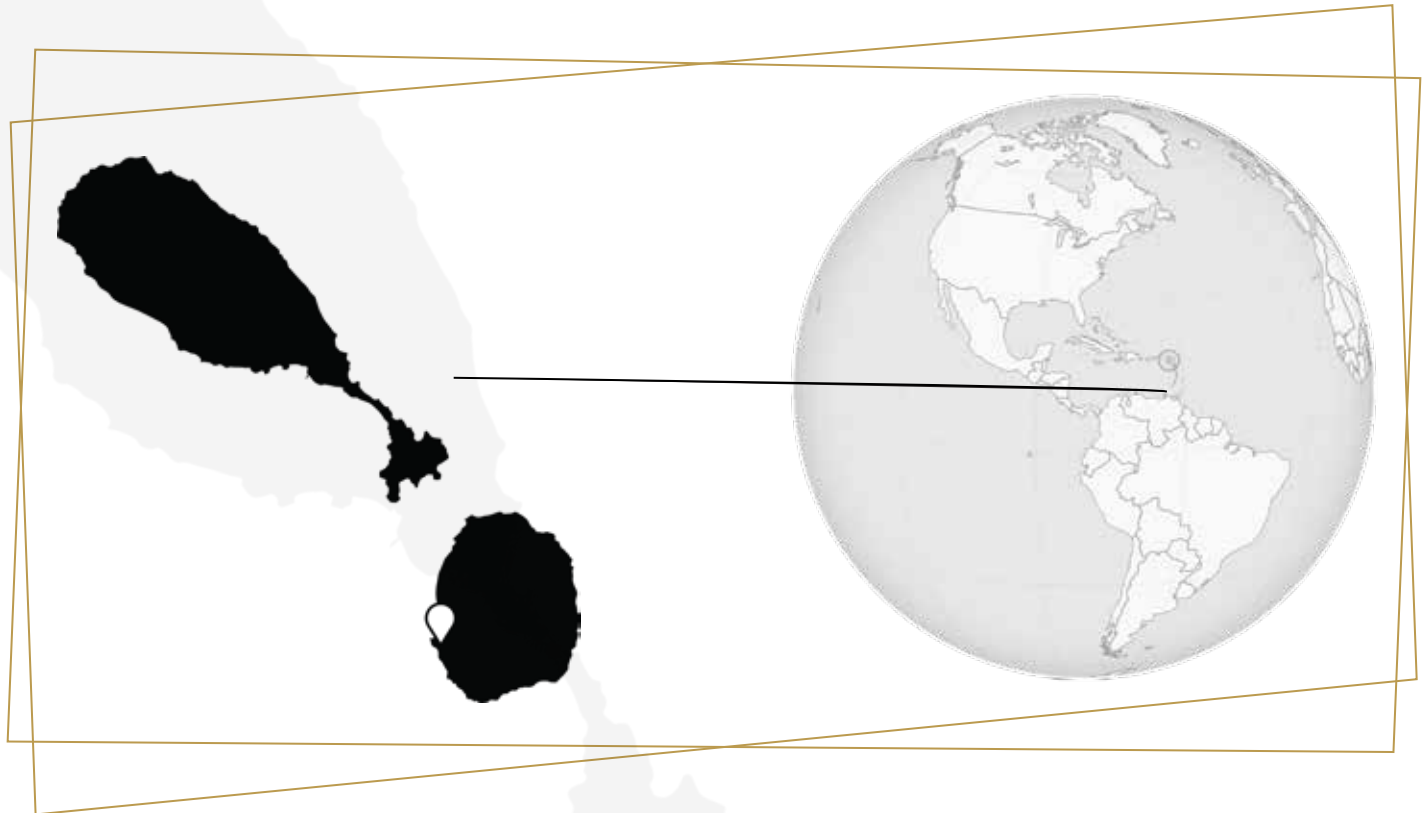

The St. Kitts & Nevis Citizenship by Investment Program was authorized in 1984 under the governance of the 1984 Citizenship Act, Part II, Section 3, which makes it the oldest citizenship by investment program in the world.

To qualify for citizenship in St. Kitts & Nevis, applicants must fulfill the following criteria:

- **Outstanding Character:** Applicants are expected to demonstrate excellent moral and ethical conduct.
- **No Criminal Record:** Applicants must not have any history of criminal offenses.
- **Excellent Health:** Applicants need to be in good physical and mental health.
