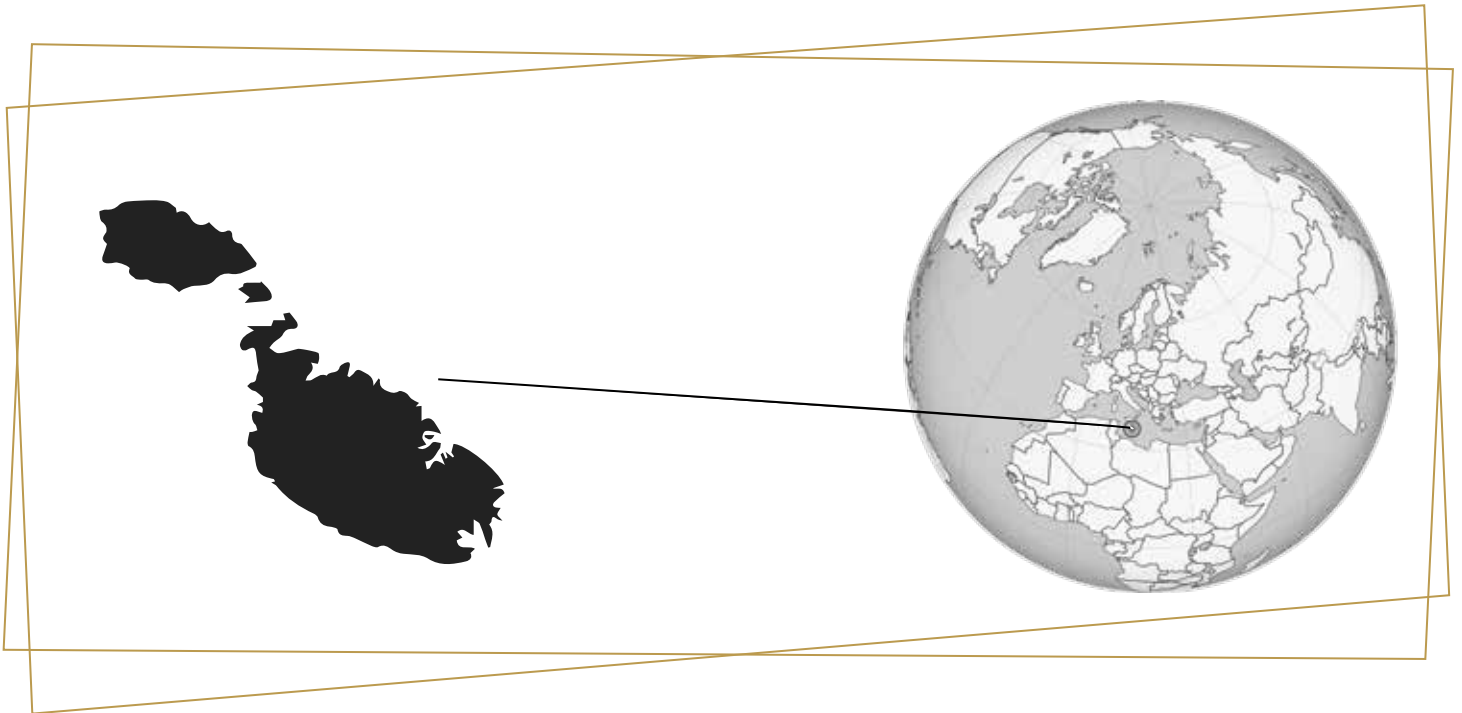


MALTA
